Day Camp Program

The Manners Park Day Camp is located in the Manners Park Dining Hall. Activities and programming will be planned around the entire park. The Manners Park Day Camp is a camp, NOT a licensed day care. For that reason, if you are claiming Day Camp on your taxes, make certain to ask for a weekly receipt. Ages for campers may range from 5 years old (**must** have completed kindergarten) to 11 years old.

Unfortunately, due to the rising cost of minimum wage Camp fees have gone up. Please make sure you read the paper work carefully and go over all safety and rules with your camper. Thank You!

Personal Belongings

Remember to label all items brought to the program. Campers will be responsible for their personal belongings. The park and day camp employees are not responsible for lost, stolen or broken items.

No toy knives, guns, or any type of weapon is permitted at camp and will be confiscated immediately. **NO ELECTRONICS!** Leave the phones, Ipads, tablets and anything else that has a screen at home.

Drop-Off and Pick-Up Procedures

Parents, guardians and those adults authorized to drop-off and pick-up your child are required to personally sign children in and out every day. Day Camp staff will only release your child to persons authorized on your enrollment form. Staff may ask for proper photo id if needed for identification purpose.

Parents, guardians and those adults authorized will also fill out COVID-19 questions when signing in camper. Campers will have their temperature taken upon arrival. Campers experiencing any COVID-19 symptoms must remain home.

Manners Park Pool

Weather permitting Day Camp will go the pool every day from 1:00 p.m. – 3:45 p.m. I recommend sending a swim shirt and hat for your camper. We sunscreen 3 times a day, but the more coverage the better. It is also highly recommended to sign your camper up for swim lessons. Campers can attend swim lessons during the morning hours of camp. A staff member or volunteer will stay at the pool during lessons. Registration forms are available on line or in the park office.

Snacks and Lunch

A morning snack and drink will be provided for all campers around 9:45 a.m. If your child wishes to bring their own snack they may do so. Campers need to bring a sack lunch every day. No food will be heated up. We do not supply an afternoon snack. Pool Concession cards may be purchased for use at the pool, or you may pack a snack for our child to take over.

Payment

Payments should be made every Friday for the upcoming week. You may pay for multiple weeks at a time. Late payments will have a \$5 late fee added to them. All returned checks will be charged a return fee of \$20 per check and all other payments must be made in cash to the park office. Children with an overdue balance will not be allowed to attend camp until their account is paid. Overdue accounts will be turned over to the Park District Attorney.

Camper Safety and Rules

- No fighting, hitting, kicking, spitting or any other physical harm will be allowed.
- Foul language will not be tolerated.
- No child may leave the dining hall, pool or day camp group without authorization from a day camp employee and must be accompanied by an authorized adult.
- If a child needs to leave day camp for another program, parents should report to camp staff or Recreation Director of their program and the time they will be returning.
- Campers will clean up all food, garbage and activity messes with staff supervision before going to another activity.
- Sharing food is not permitted, and all food and drinks must be kept on a table while being consumed.
- All clothing, towels, sunscreen, lunch boxes, etc. should be clearly marked with the child's name. The staff will not be responsible for personal items lost, stolen or broken.
- All property of the park and day camp program will be respected.
- Campers and parents are asked to follow the Manners Park Day Camp rules.
- Campers experiencing fever, chills, cough, shortness of breath, fatigue muscle aches, headache, loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, diarrhea or any other COVID-19 symptoms must remain at home.

We hope that all campers can participate in a happy, safe, environment, however, should a child be out of control, jeopardizing the safety of the other children or continually disregards the camp rules, he/she will be taken out of camp immediately, and a phone call will be made to the parent or guardian to have the child picked up as soon as possible. If negative behavior continues, you will be asked to withdraw your child from the program.

*Application must be completed in full and returned to the office with the first week's payment. Payment is non-refundable.

I understand and acknowledge that the enrollment of minor and their participation in The Manners Park Day Camp is wholly voluntary and that there are physical risks and hazards connected with participation, including, but not limited to the risk of communicable disease such as COVID-19. I understand, acknowledge, and agree that the Taylorville Park District is not responsible for and does not assume the costs of any medical testing, care, or treatment associated with the Minor's participation in Day Camp, including, but not limited to, any medical testing, care, and treatment of the minor or anyone with whom the minor may have contact during or after the minor's participation in Day Camp.

With regards to the risks posed by COVID-19, I acknowledge, understand, and agree:

- A. That the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization and, as a result, Day Camp is being delivered during a time of national public health crisis;
- B. That COVID-19 is extremely contagious and there are risks, known and unknown, associated with the Minor participating in Day Camp;
- C. That the minor, other children, other participants, volunteers, employees and group leaders may be infected before and/or during activity and could transmit COVID-19 without displaying any symptoms;
- D. It is my responsibility to manage the risks to minor, myself, and others the minor may come into contact which are associated with COVID-19;
- E. That the Taylorville Park District cannot guarantee that minor, or others with whom the minor comes into contact with during and after participation in Day Camp will not become infected with COVID-19.

I agree, on my own behalf, on behalf of minor, and behalf of others acting on my behalf to comply with all Taylorville Park District rules and regulation regarding minor's participation in Day Camp, including all rules and regulation that pertain to COVID-19. I understand and agree that noncompliance with any such rules and regulations by myself, minor, or anyone acting on my behalf may result in termination of minor's participation in Day Camp. I further understand and agree that if minor or anyone minor has had direct recent contact with exhibits symptoms of COVID-19, as set out by the U.S. Centers of Disease Control, on the day of or within 14 days prior to Day Camp, minor will not participate in Day Camp. I understand and agree that if minor exhibits symptoms of COVID-19, as set out by the U.S. Centers of Disease Control, during Day Camp, minor will be required to leave Day Camp immediately and notification must be given to

the Taylorville Park District. I understand and agree that any registration, activity, or program fees will not be returned if minor's participation in Day Camp is terminated under either of these circumstances. I understand and agree that if minor or anyone minor has had direct contact with exhibits symptoms of COVID-19, as set out by the U.S. Centers for Disease Control, within 14 days after the activity, I will immediately provide notice of the same to The Taylorville Park District.

Having been given sufficient time to read and review the above acknowledgements, understanding, and agreements, I hereby consent to the minor's participation in Manners Park Day Camp.

I voluntarily agree to assume all risks, known and unknown, and accept sole responsibility for any injury to minor, myself, or others with whom we may come into contact, including, but not limited to personal injury, disability, death, illness, damage, loss, claim, liability, or expense of any kind, that I, minor, or others who may come into contact with us may experience or incur in connection with minor's participation in The Manners Park Day Camp. On my behalf, and on behalf of minor, our heirs, and our legal representatives, I hereby release, covenant not to sue, discharge, and hold harmless the Taylorville Park District, its successors, assigns, employees, Board members, officers, officials, administrators, agents, and volunteers from any and all claims, causes of action, suits, expenses, debts, accounts, controversies, damages, claims and demands arising out of the minor's participation in The Manners Park Day Camp.
